What We Use Cookies For

Karibu AWSG uses Wix Analytics to analyse the use of this website. Wix Analytics generates statistical and other information about website use by means of cookies, which are stored on users' computers. The information generated relating to our website is used to create reports about the use of the website.

Karibu also uses a cookie to not show repeated reminders of our Cookie Policy.

Refusing cookies

In Firefox, you can adjust your cookies settings by clicking "Tools", "Options" and "Privacy".
